- It is the responsibility of the Consignor to reserve a spot for their bull(s) and ensure that they are conditioned and in good health at delivery to the bull centre. Each client must complete this form and deliver it to the centre manager on delivery day.**
- Make the most of your testing year! AgSights strongly recommends that you submit whole herd data for accurate genetic evaluations.** AgSights accepts herd data through bioTrack, AgSights Calving, Cow and Sire Worksheets, or Breed Association birth and weaning reports. There are a variety of cost options to fit with your budget. If we don't receive at minimum a birth date on the bull they will not appear on the bull report.
- Vaccinations and Entry** - Vaccination requirements are at the sole discretion of the centre manager. The centre manager may also have other entry requirements in addition to these:
 - Bull calves must weigh a minimum of 500 pounds at delivery and have a legible tattoo. Tattoos are the responsibility of the bull's consignor. Centre managers can verify tattoos at the time of delivery.
 - Calves must be in good health and bull calves must have two normal testicles.
 - Calves must be properly dehorned and healed.
- Fees** - Be sure you understand the costs before you deliver your bull. Fees should be established between the consignor and the Centre Manager. Additional fees for herd information can be quoted from AgSights and will be payable to AgSights.
- Bull and Heifer Health/Insurance** – AgSights will not be responsible for any damages or losses however incurred. Bull and Heifer insurance is the sole responsibility of the client. Clients are advised to obtain the appropriate insurance coverage prior to the entry of the calves into the centres.
- The Centre Manager** shall be entitled in emergency situations as determined by the Centre Manager to retain veterinary services, including the right to have an animal destroyed if in "extreme suffering".
- Release of Information** - Information about the bulls and heifers, their measurements, the evaluation, client name and phone number will be published on reports and potentially AgSights' website for promotional purposes. You should notify AgSights in writing within 14 days of the bull and heifer delivery if you do **not** want AgSights to release information including but not limited to publishing on the Internet.
- Late Submission of Data Policy** – No changes or additions to information on bull evaluation reports/heifer development reports will be accepted after the scheduled end-of-test date. No groups will be recalculated after the end-of-test report has been generated.

Provision and Use of the Information Provided by AgSights

As part of the terms and conditions of AgSights' Bull and Heifer Evaluation Services, it is understood that information provided by AgSights including, but not limited to, genetic and carcass evaluations are produced using the very best knowledge available and are pursuant to generally accepted industry standards.
